

ILOG Academic Software License Agreement

PLEASE READ BEFORE USING THIS SOFTWARE

IMPORTANT: The use of the Software is subject to all terms and conditions of this Agreement. By completing the software installation process you acknowledge and accept the terms of this Agreement. This software and accompanying documentation (Software) are a product of ILOG. In this Agreement "ILOG" means ILOG S.A and its Subsidiaries. The "Licensee" or "you" means the Academic Institution Department mentioned in the ILOG Academic License Order Form or in the ILOG Academic License Upgrade Form. The Software is copyrighted and contains confidential and trade secret material.

ILOG grants to Licensee non-exclusive, non-transferable, license to use and display the Software for the number of Computers specified in the written document provided to you, which is incorporated herein by reference, at a single location.

YOU MAY: Use the Software for non-commercial purposes including conducting academic research or providing educational services. You certify that use is directly related to teaching or that use is strictly for noncommercial research by students and faculty members where

1. the results of such research are not intended primarily for the benefit of a third party
